This Certificate is intended for getting CBSE, AICTE affiliation for Schools/NABA accreditation for Hospitals/star classification for Hotels only and not for getting occupancy certificate from Local Self Government Departments.
3. This Fire Safety Certificate pertains only to the Fire Fighting arrangements made and installed in the building.
